

# Somerville publishes city's first bicycle network plan



After a long time coming, the City of Somerville has established a citywide Bicycle Network Plan.

On Tuesday, April 11, the City of Somerville announced that it has adopted a plan for a bicycle network. A public statement was released stating the following:

After more than a year of engagement, research, and analysis, the City of Somerville has released Somerville's first-ever citywide Bicycle Network Plan.

The Plan documents Somerville's community-based vision for an 88-mile network of connected streets and paths where people of all ages and abilities will be able to bike safely and comfortably. Compared to the fragmented 30-mile network that exists today, the Bicycle Network Plan envisions a future with vastly more biking

# First Look Exhibit to kick off Somerville Open Studios



# The judge will let him back in

Somerville Police officers were dispatched to the Dunkin' Donuts on Broadway last Thursday morning on reports of an unwanted, apparently unwanted inebriated man inside the store refusing to leave

Upon arrival, the officers were met inside by the reporting party and store manager. As soon as the manager started to explained to them what was taking place, a man, later identified as Leodan Salmeron-Molina, reportedly walked over and started to yell at the manager in an apparent attempt to prevent her from speaking to the officers.

Salmeron-Molina was immediately escorted outside and it was explained to him that if the Dunkin' Donuts staff asked him to leave because of his disruptive behavior, he had to leave. However, Salmeron-Molina was reportedly very agitated and refused to

let the officer speak further.

The officer was able to explain to Salmeron-Molina that he was trespassed from the store and if he was to return inside, he would be subject to arrest, to which he reportedly replied, "I will go back inside." The officer repeated numerous times the consequences of going back inside.

As soon as the officers left, Salmeron-Molina went back inside the store, prompting the manager to run to the police cruiser as they were driving around the block back into the parking lot of the Dunkin' Donuts.

Once the officers arrived back at the store, Salmeron-Molina reportedly started to walk outside. Once he was outside, the officers attempted to place him under arrest, but he refused to turn around and a brief struggle took place.

Salmeron-Molina was taken to

the ground and the officers asked him to put his hands behind his back, at which time he complied.

Salmeron-Molina was placed under arrest on charges of trespassing, resisting arrest, and witness intimidation.

Once the transport vehicle arrived, Salmeron-Molina reportedly stated to the officers that the judge was going to let him go and he was going to go back inside the store.

infrastructure and better connectivity so that residents, workers, and visitors can bike to schools, parks, jobs, businesses, and other key destinations in Somerville and across the region. Somerville joins Cambridge as the only municipalities in Massachusetts to establish a citywide bicycle network plan.

"It's imperative that we lay the groundwork now to create a safe, sustainable future for transit in Somerville," said Mayor Katjana Ballantyne. "Our residents want city government to act with urgency to save lives on our streets, to reduce carbon emissions, and to create more freedom and choice in how we get around. The Bicycle Network Plan establishes our path forward to do just that. I'm grateful to the more than 1,000 community members who helped shape this vision for Somerville's future. I continue to direct City agencies to work together to implement the Plan in a transparent manner consistent with public input."

The Bicycle Network Plan identifies a high-priority 40-mile network of bike facilities to be installed by 2030, with the full 88-mile network forecasted to be installed within 20 years. The network includes a mix of protected bike facilities, off-street

paths, and traffic-calmed backstreet "Neighborways" routes. The Plan designates some type of bikeway on 54% of Somerville's streets. The city will continue to hold public engagement processes before installing any facilities identified in the Plan. The city expects to evaluate the Plan every 5 years.

"In recent years, Somerville has made important progress in creating streets that are safe and inviting for people riding bikes," said Mayor Ballantyne. "Even so, I often hear from constituents who are eager to bike more but are deterred by safety concerns. As a long-time bike rider myself, I understand those concerns first-hand. We need to expand and improve our infrastructure so that biking is a safe, convenient option for traveling from one place to another. Our new Bicycle Network Plan will help the city move even faster to keep people safe on our streets."

Somerville's Bicycle Network Plan was produced through extensive community engagement, with a focus on reaching groups historically excluded from planning processes. City staff held community meetings and mapping workshops, hosted pop-up events in parks and schoolyards, conducted public surveys in multiple languages, offered community bike rides, and made presentations to the Somerville City Council. A draft of the Plan was published in December 2022 and revised based on public comment. The priorities expressed by the community, as well as those established in the City's Vision Zero Action Plan, Somerville Climate Forward climate action plan, and SomerVision comprehensive plan, guided the devel-



walkable, bikeable, transit-oriented city in the country, and establishing Somerville's first Bicycle Network Plan is crucial to making that commitment a reality," said Somerville Mobility Director Brad Rawson. "A well-connected bike network will encourage ridership and expand equitable access to transit. With our vision clarified, we can accelerate our work with the community to create safer streets in Somerville."

The Bicycle Network Plan will be a key resource for both the city and the Somerville community. Documenting the future bike network will create predictability for residents and workers and help them anticipate changes to streets across the city. The Plan will also help guide public and private investment street by street, and it forecasts the financial resources needed to plow snow and perform other crucial maintenance activities as the bicycle network grows.

# **Public Health and Safety Commission discusses** Covid-19 status, homelessness, and record keeping

The Public Health and Safety Commission of Somerville met on Tuesday, April 4, to discuss the ending of the federal Covid-19 public health emergency, updates on the efforts to provide shelter to unhoused individuals during the harsh winter months, and discuss record keeping with the Somerville Fire Department.

The ending of the federal Covid-19 public health emergency status has impacted many nationwide. In many cases, it has

removed covid era restrictions entirely and ended the national emergency support. The Public Health and Safety Commission discussed the impact this would have on the city's residents regarding access to testing, vaccines, and other covid support resources.

During the meeting, the Commission also spoke with the Director of Health and Human Services to receive an update on the efforts to provide warming centers for unhoused individuals during the recent cold spell. Last year the Somerville Homeless

7,000 individuals. Members of the leadership team, Michael Libby and Hannah O'Halloran, said at a presentation two months ago that the organization focuses on getting unhoused individuals long-term needs through their programs.

They help these individuals transition into new homes and help support them through rebuilding their life. Libby and O'Halloran also commented on the warming centers stating that volunteers are critical to making

warming centers become a reality because without them there is a lack of staffing resources due to being spread out throughout the different programs offered.

The last discussion point on the agenda was the discussion of record keeping for the Somerville Fire Department in coordination with the director of housing stability. The council discussed with them collaboratively the feasibility of conducting annual reporting on the following matters; the number of fires, the causes of those fires, the numbers dis-

placed by each fire, and if those displaced were able to relocate within Somerville or not.



# Somerville School Committee selects Dr. Rubén Carmona as next Superintendent of Schools

Following a months-long search process, at their meeting on Monday, April 10th, the Somerville School Committee selected Dr. Rubén Carmona to serve as the next Superintendent of the Somerville Public Schools. Dr. Carmona was one of four finalists who participated in site visits and public interviews during the week of March 27.

"I'm honored to welcome Dr. Carmona to the Somerville Public Schools. Dr. Carmona's commitment to instruction, equity, and instructional excellence shown through in his interviews and site visits to our district. I truly believe that Dr. Carmona has the potential to be a transformative leader, and a leader that will fit very well within our diverse urban school community," said School Committee Chair, Andre Green. "I want to thank all of the candidates who worked with us

over these last few months. We had a hard choice before us but I know Dr. Carmona is the right choice in this moment for our entire district. Congratulations and welcome to the team."

"I am privileged to lead the work at the Somerville Public Schools am grateful for this opportunity. I am excited to learn from and listen to all of the stakeholders in Somerville to best support all learning in the community," said Dr. Carmona. "Somerville's commitment to addressing academic inequities, academic excellence, and to supporting students through the whole child approach is important to the way I also approach the job, and I am excited to begin my tenure in the Somerville Public Schools."

Dr. Carmona currently serves as Executive Director of Family, Community and Employee Engagement in the Salem Public Schools. Previously he was the Regional Recovery Academic Director in Boston, and a Principal in Salem and Lowell. Dr. Carmona has 15 years of teaching experience working in Bilingual Education and dual language programs. He obtained his undergraduate training in Modern Languages/Linguistics at the Universidad del Valle-Cali in Colombia before obtaining Master's Degrees in Business Administration and Educational Leadership at Salem State College. In 2012 he obtained his Ed.D. in Educational Leadership at Boston College.

Dr. Carmona will assume the Superintendent role in Somerville as of July 1, 2023, following formal negotiations with the School Committee.

Current Interim Superintendent of Schools, Dr. Jeff Curley,

will depart the Somerville Public Schools district in July after more than six years in Central Administration, including Chief of Staff to former Superintendent Mary Skipper. Dr. Curley will support the incoming Superintendent as needed through the summer transition.

"Alongside my colleagues on the School Committee, I want to be the first to formally welcome Dr. Carmona to the Somerville Public Schools," Dr. Curley said. "Dr. Carmona will be joining a stellar team of educators, administrators and staff, and overall school community. We are all excited to welcome you to our district, and will be ready and eager to get right to work with you on day one to ensure a smooth transition in July. Thank you to everyone in the SPS community who lent your time and energy to this process. We are fortunate

## Somerville workers and small employers invited to employment-based residency info session

The City of Somerville and Pathways for Immigrant Workers will host a free immigration legal information session for small employers and lower-wage workers on Wednesday, April 12, from 6:00 to 7:30 p.m. at the East Somerville Community School Cafeteria located at 50 Cross St.

The information session will share how small employers can sponsor lower-wage workers for employment-based permanent residency. Employers and workers will be invited to schedule an individual assessment with Pathways for Immigrant Workers to determine eligibility to receive pro-bono legal representation for qualifying workers.

To find out more, and register in advance, email info@myimmigrantpathway.org. Registration is not required to attend the workshop, and walk-ins are welcome.

Interpretation in Spanish, Portuguese, and Haitian Creole will be available and additional languages may be requested by emailing somerviva@somervillema.gov or calling 311 at 617-666-3311.

Pathways for Immigrant Workers is a Cambridge-based non-profit legal organization that assists lower-waged workers and small employers with employer-sponsored green card applications. The organization provides pro-bono legal representation to eligible small businesses who otherwise would not have the means to obtain legal representation to sponsor their employees.



### Breakfast Sandwiches

6 English Muffins

These make ahead breakfast sandwiches will save you plenty of time during the week whether you're off to work or school. They can also be frozen if you want to make extra.

6 Eggs6 Slices Cheese, Cheddar, Swiss...6 Slices of Canadian Bacon,12 Slices

Bacon, Sausage Pattie or Ham Salt & Pepper

Precook the bacon and or sausage patties and set aside. Toast the English muffins. To cook the eggs, I use individual silicone rings to keep the shape uniform, of course this is optional. Place the prepared silicone rings in the

bottom of the nonstick frying pan.

In a small bowl, scramble the eggs, season with salt and pepper, and evenly pour the egg mixture into each silicone ring and cook. Assemble the sandwiches. Place the cooked eggs on the bottom half of the English muffin, add the cheese slices, place the bacon, or sausage on the eggs, then If you're going to eat them right away, no need to scramble the egg, just crack it in the silicone ring, season with salt and pepper to taste and leave the yolk runny if you prefer.

If you plan on freezing, wrap each one individually in wax paper and store in the refrigerator for a couple of hours to make sure they are totally cooled down before placing them into a ziplock bag and storing in the freezer. They should be good for up to a month.



To reheat, place the sandwich in the microwave and heat for 45 seconds to 1 minute or longer.



## **Andrea Read:**

## Of Academic Pedigree and the Common Touch

I met with poet Andrea Read after I heard about her work for the Somerville Cultural Capacity Plan (https://somervilleartscouncil.org/culturalcapacity) that will happen in late April. This project will involve conversations with artists and writers. Read will lead the discussion with writers, asking them pointed questions about their needs in the community.

Read told me she was previously renting an apartment in Cambridge, but she kept going through Somerville on her way to the Home Depot. She reminisced, "I loved that Somerville was hilly, and I could see a lot of vegetable gardens around. I felt at home in Somerville." So eventually she bought a house (not far from where I interviewed her, the Bloc 11 Cafe) and seems to be happy with it.

In 2015 Read, who has a PhD in Romance Languages from the University of Chicago, got her MFA from Lesley University. She told me, "I had fabulous teachers, such as Kevin Prufer, Steven Cramer, Cate Marvin Teresa Calder, and others."

Back in the day, Read worked in the theatre as a dramaturge, where she read original scripts, in order to decide what the theatre might be interested in. She worked at the Organic Theatre in Chicago. Later, when she was studying poetry and art in Spain, she loved the fact that other poets and artists mentored her. She reflected, "But in the states it is different, so I decided to go to the low residency program at Lesley. I was at a crossroads in my life. I could have been an academic or poet. I chose to concentrate on

A number of years back Read started running a poetry group for the Little Sisters of the Poor (now run by the VNA) on Highland Ave. in Somerville.



Read told me about her experiences there saying, "With this group there were special challenges. Although the group membership are not cognitively challenged, I have to make accommodations with folks who have hearing and vision issues, for instance. The same people who joined in 2018 are still coming to the group, unless they passed away, of course. The members are not filtered, they say what is on their mind. They are open to the creative exercises that I bring to the plate. One member who used to travel a lot and cannot now said she now travels in her imag-

Read is a strong advocate for poetry as a healing agent. And indeed, Read brings poetry and healing, here, in the Paris of New England, Somerville, Ma.
