Somerville's 'Comedy Studio' faces uncertain but hopeful road to reopening

As COVID-19 vaccination rates rise in Massachusetts, many of the state's live performance venues are finally eyeing reopening after over a year of closure. While indoor venues elsewhere in Massachusetts begin to reopen, Somerville's local government has taken a more cautious approach, barring indoor performances, and restricting some forms of outdoor performance that involve high rates of aerosol projection.

Rick Jenkins, owner of The Comedy Studio in Somerville, says the pandemic has placed his business in an increasingly precarious position. Over the past year The Comedy Studio has received aid from Somerville, the State of Massachusetts, and the Federal Government.

While this aid allowed Jenkins to retain his staff for much of the pandemic, in January, facing drastically reduced revenue, he was forced to furlough the theater staff in

Little free libraries engage readers during COVID

Copies of Kerouac's *On the Road*, Sue Grafton mysteries, and an American cookbook line the shelves of Ellie Botshon's Little Free Library on 28 Jay Street. While she has housed the structure on her property for about five years, similar book collections have been popping up all over Somerville for some time now, offering passers-by the opportunity to pick up a read or donate their own.

"It started with my sister, who is an English literature professor," said Botshon. "She got one for her house, and I loved the idea, so I got one as well. At the same time, ironically, my business partner and our assistant also got a Little Free Library in their house, and we work together. It's a nice way of connecting with each other and the people in the community. It gets used daily, and it's cool to watch, seeing what books come in and go." She added, "It's

"Wow! Nobody believes me when I tell them about this truck!"

A hot summer's night, many years ago. People sitting on their front porches. Kids with popsicles and the sound of fans in windows. A truck pulls up and all the kids run over to it, but it's not the ice cream man. After stopping and getting money from their parents, the kids line up for a ride on The Whip! Along with

the frenzied kids, what I remember most was the sound of the motor and the smell of exhaust. But boy was it a blast!

In the photo, one of the trucks says Uncle Sam. Now here comes the Somerville connection. When they saw the photo on Facebook this was the reaction:

"My wife's Uncle! Slamming Sam Pino, Boston University Football Hall of Fame! Running Back, Drafted and played for the Green Bay Packers with Bart Star."

More memories started pouring in reacting to the photo. "I remember this truck coming to Albion St. and it cost



10 cents. Trying to explain this to others is almost impossible for anyone to comprehend, if you never heard of it before." Indeed! A truck that went from neighborhood to neighborhood that had a fun filled amusement park ride? It's no wonder that the memories of The Whip were so numerous.

"Omg! I remember this coming to Magnus Ave. We always rode more than once. I told my kids about this and they thought I was crazy, now I can show them it was real."

"I still remember the excitement of seeing it come down the street (Montrose). And, weren't we always outside, playing on the street?"

"We used to yell faster, faster and it seemed like it did go faster ... the driver could throttle up the engine to make it go faster!"

My friend Phil recalls, "I remember my sister Linda giving me a dime to ride it.

She became my hero then."

"I remember going to the Star Market parking lot back in 1971. That was part of the small carnival they set up every year. Kids would be wearing neck braces the next day. No one sued."

Can you imagine if The Whip truck came around today? There's probably new safety rules and restrictions in place.

I'll go out on a limb here and say that we kids took lot of chances back in the day. We played on the railroad tracks, and right in the middle of the street. We also gathered in city parks and played sports! remember leaving my house around 8:30 a.m. and not getting home until after dark. We thrilled when the traveling carnivals set up for a few days. We made a bee line for the ice cream truck but when The Whip came around, it was special.

It's no wonder that a friend made this comment: "One of my all-time favorite memories!"

Additional types of outdoor performances, outdoor retail can resume April 19 in Somerville

With vaccines being made available to all residents over 16 beginning Monday, April 19, the City of Somerville will expand its reopening guidelines to allow more types of outdoor performances and outdoor retail to resume on that date. The city will also work with gyms on plans to safely reopen changing rooms and showers.

Outdoor performances that may cause moderate aerosol spread, including theater, comedy, and spoken word performances, will be allowed under guidelines previously established for outdoor performances. Activities like singing and playing wind instruments are not currently allowed.

- Outdoor retailers must still follow City permitting requirements:
- Flea markets must apply for a public event permit through CitizenServe.
- Individual retailers must apply for a permit through CitizenServe.
- Artists without a storefront have the option to work with an existing business to set up in front of its store and go through the individual retailer process or follow the flea market process to set up shop in a public space.

The City of Somerville continues to monitor COVID case trends, vaccination rates, and other related data on a daily basis. As more people are vaccinated there is hope for further reopening in the near future.

Too upset to be booked

Somerville Police officers were dispatched to Bairos Liquors on Broadway last Saturday evening on reports of an intoxicated customer who refused to leave the store after the manager refused to sell liquor to the defendant, Tyler Manning.

The store manager told police that he refused to sell liquor to Manning because of his level of intoxication. According to the

manager, Manning began to threaten him by saying, "I'm going to kick your ass. Come at me, I'll beat you up."

The manager said that he then informed Manning that he was calling Somerville Police.

Manning reportedly shouted at police, almost nose to nose with one of the officers on the sidewalk. As officers approached him, Manning took a combative

stance and began shouting and threatening them.

Manning was ordered numerous times to leave the area by one officer, but he reportedly belligerently shouting at the officer, and then chest bumped him.

Manning was pressed up against the building and then placed on the ground with an arm bar takedown.

A struggle ensued as Manning

was placed in handcuffs. He was then informed that he was under arrest. Manning reportedly made numerous attempts to get up and lunge at officers. He was then placed on a bench, and continued to try to get up and lunge at them, but he was held down on the bench by force.

Manning was placed in a police transport vehicle and taken to the station for booking

on charges of resisting arrest, threat to commit a crime, and disorderly conduct.

According to reports, the booking officer was unable to book Manning because of his behavior. He was placed into a prisoner cell so that he could have some time to calm down in the hopes that the officer in charge could finish the booking process.

Hit-and-run driver sought by police

Troopers from the Medford Barracks, Collision Analysis and Reconstruction Section, and Crime Scene Services Section continue to investigate a hit-and-run crash that caused serious injuries to a pedestrian last night on William McGrath Highway (Route 28) at Broadway in Somerville. The victim, a 72-year-old Somerville man, was transported to Massachusetts General Hospital with potentially life-threatening injuries.

Troopers responded to the scene at 8:40 p.m. after State Police, Somerville, and regional dispatchers all received calls reporting a pedestrian was down on the roadway and was injured. Responding Troopers determined that the victim had been struck by a vehicle while crossing McGrath Highway from east to west. At the time he was hit, the pedestrian was apparently coming from the nearby Stop & Shop supermarket and was carrying several bags of groceries.

Evidence gathered to date suggests the vehicle that struck the victim was a white minivan or SUV. The vehicle sustained front-end damage in the crash, including a damaged headlight. an effort to reduce expenses. Jenkins has already outfitted The Comedy Studio with plexiglass barriers and reduced seating in an effort to make the space safer. Despite these retro-fittings, The City of Somerville has yet to give the green light on indoor performances.

Across the Charles, Norm Laviolette, owner of comedy venues Laugh Boston and Improv Asylum, has already begun to host in-person shows at 50% capacity. Despite a sell-out crowd the weekend of Improv Asylum’s re-opening, Laviolette fears for the long-term health of his business. "The reality of the 'fifty percent open' is that you can't sustain on that. You can get your businesses started, and that's what we're doing. But none of these businesses are going to be able to survive in the long haul at fifty percent."

The pandemic has forced both

Jenkins and Laviolette, two multi-decade veterans of the Greater Boston comedy scene, to drastically shift their businesses towards online content. Zoom was a radical new format for stand-up comedians, demanding a shift in both their presentation and material. Jenkins explains, "The material is becoming a lot more personal and a lot more intimate. A lot less 'jokey.' You're looking in the eyes of your audience in the little boxes. There's no 'blinded by the lights,' it's very clear you're talking to someone."

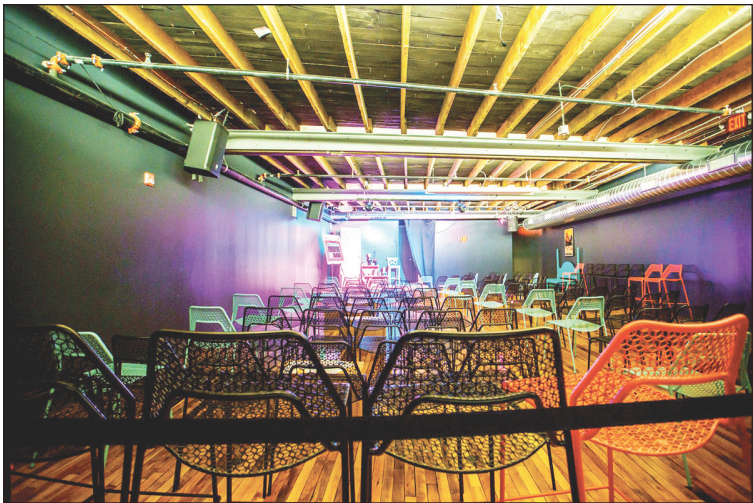
Laviolette plans to stream shows at his venues even after the pandemic. "We're gonna be offering online streaming tickets for almost every show that we sell there. And that's great, because now you take your 300-seat club. Well, now it's a 500-seat club, or 1000 seat club."

Though Somerville Mayor Joseph Curtatone is sympathetic

to local business owners, he is also well aware of the grave ramifications of the ongoing pandemic. "I'm acutely aware there are financial impacts," Curtatone explained, "but I'm also the person who gets the phone calls when 84 people die in my community. We will not do anything to put people's lives at stake."

Towards this end, the Mayor's Office has doubled down on making outdoor dining and performance spaces more accessible: waiving \$750,000 in permit fees, and removing almost all financial barriers to make the outdoors more accessible to Somerville business owners.

Though the future of Somerville's indoor performance venues remains uncertain, outdoor comedy has a bright future. On April 12 a spokesperson for the city wrote: "As of 4/19, comedy performances will be allowed outdoors. Indoor comedy performances are currently not al-



lowed in Somerville due to the continued high covid case rate in Greater Boston and the Commonwealth and the higher risk of indoor activities."

In challenging times, Laviolette believes the arts are essential. "It's the artists that help us get through psychologically, right? They're needed. It's not a 'nice-to,' it's a 'need-to.' So, remember that. Remember that's what got us through the dark days, so let's go out and let's support them as

better days are ahead."

City Council addresses hostile architecture, police use of force

The April 8 City Council meeting saw many resolutions passed, including that one appointing the Director of Mobility and Commissioner of Public Works work with the State Delegation to remove hostile architecture from the Davis Square MBTA station, as well as to ensure that no hostile architecture continues to be installed around the city.

Hostile architecture is specifically designed to target vulnerable populations such as the homeless to “push them out of an area” as Robert Rosenberger an associate professor of Philosophy at Georgia Institute of Technology writes.

Hostile architecture features in the MBTA stop at Davis

Square consist of armrests in benches, which at first were designed to be in compliance with the Americans with Disabilities Act, but have gradually made them harder for people to use in the way that homeless people have been using them for years. This includes resting, sleeping, and reclining in comfortable ways.

It is, in effect, a way to push homeless people away from public spaces and out of the public eye. If the problem cannot be seen then the problem is not there, as some might see it.

Another important agenda item addressed was the unanimous approval of the regulation of chemical crowd control agents and kinetic impact projectiles. As stated in the briefing, “The

use of pepper spray by the SPD or any other law enforcement officer shall not be permitted unless an emergency exists that requires the immediate use of Pepper Spray to prevent serious bodily injury or death, (A) an Officer personally witnesses on going and illegal acts of violence, property destruction, imminent threats of violence, or imminent threats of property destruction involving a weapon, (B) is unable to arrest or detain an individual using a lower level of force, and (C) provides a clear verbal warning of the imminent deployment of Pepper Spray prior to its use and affords a reasonable opportunity for the individual(s) to cease and/or comply.”

These changes come in the wake of the George Floyd killing

that occurred in Minneapolis last year, where alleged excessive force by a police officer used in an arrest ended in the death of the detainee.

This change in policing tactics has been a common dis-

cussion in the Somerville government as seen in previous statements by Ward 5 Councilor Niedergang concerning reduction of the number of police officers in the city and how conduct their duties.

Pearl Street mobility improvements public meeting

Little free libraries engage readers during COVID

everything from Harry Potter for kids, to fiction, to a Java computer writing book. It's a very eclectic bunch of books. A lot of them are best sellers, and then you always get one or two that are like, what is this?"

A Little Free Library is a miniature house, often with shelves, that sits on a person's land outside their actual home. Curators like Botshon can support the circulation of books by depositing their own titles, but the way the libraries work is that anyone on the street can stop over and grab one for free or leave behind their unwanted texts. Botshon painted hers dark red to match her house and dug a hole in the ground, making the library sturdy by adding cement. She said that she has many regular visitors.

"Over the past year, there's been a very even flow of books going in and out," said Botshon. "It has its own culture. It has its

own life. Every day is different."

Rivkah Lapidus and Todd Kaplan have a Little Free Library called The Book House on 44 Kidder Avenue. They created theirs when they realized that they had an excess of books in their house that they wanted to clear out. The process of rotating the volumes quickly became very "interactive," and Lapidus even left a notebook out so that people could leave comments, saying what they took or what they liked. Theirs was envisioned to be bigger than most and was even mistakenly rated as a "bookstore with a poor collection," due to its size and on-going traffic.

"I think there's a huge hunger for books, and there's not a lot of resources," said Kaplan, speaking to the void in the community that the library fills. "We have one bookstore that's within one mile and one other within a couple miles, but there used to be

lots more. People actually drive here. We have people who walk by on 'Little Free Library Tours,' trying to go all over the area."

Emily Bhargava, who has a Little Free Library on 63 Irving Street, said that it has been practical for the city to have these miniature houses during the coronavirus. For people who cannot physically enter an actual library or bookstore, visiting the Little Free Libraries gives them a way of finding new reads. Other community members may incorporate a stop at one of the libraries as part of a regular walk around the neighborhood, while Bhargava added that she thinks many people see them as a destination as they spend some time outside. Incidentally, some have begun using the libraries as food pantries, sometimes leaving nonperishable cans or goods to help those in need. Caretakers like Ruth Faris, who has a library on 6 Spring Hill Terrace,

even held a COVID-friendly decorating party, where she invited local kids and residents to paint her own library, wearing masks and social distancing through the process.

The presence of the Little Free Libraries brings an element of whimsy and creativity to the neighborhood, said Botshon. They build community and have even created a subculture in Somerville, with even people from neighboring towns making a point to visit specific locations. Encouraging people of all ages to read, the libraries promote literacy among children and adults alike.

"Books are important for our society, and any way that you can create access is important," said Botshon. "Especially during COVID, when libraries are mostly closed—you can order books online and then pick them up somewhere—but it's not easy access to browse. It

gives people a way of browsing. It's also interesting to see what other people are reading, what they put there, or what they had in their house that they brought over." She added, "It is important, overall, for people to get excited by literature and learn about different things that they don't know about."

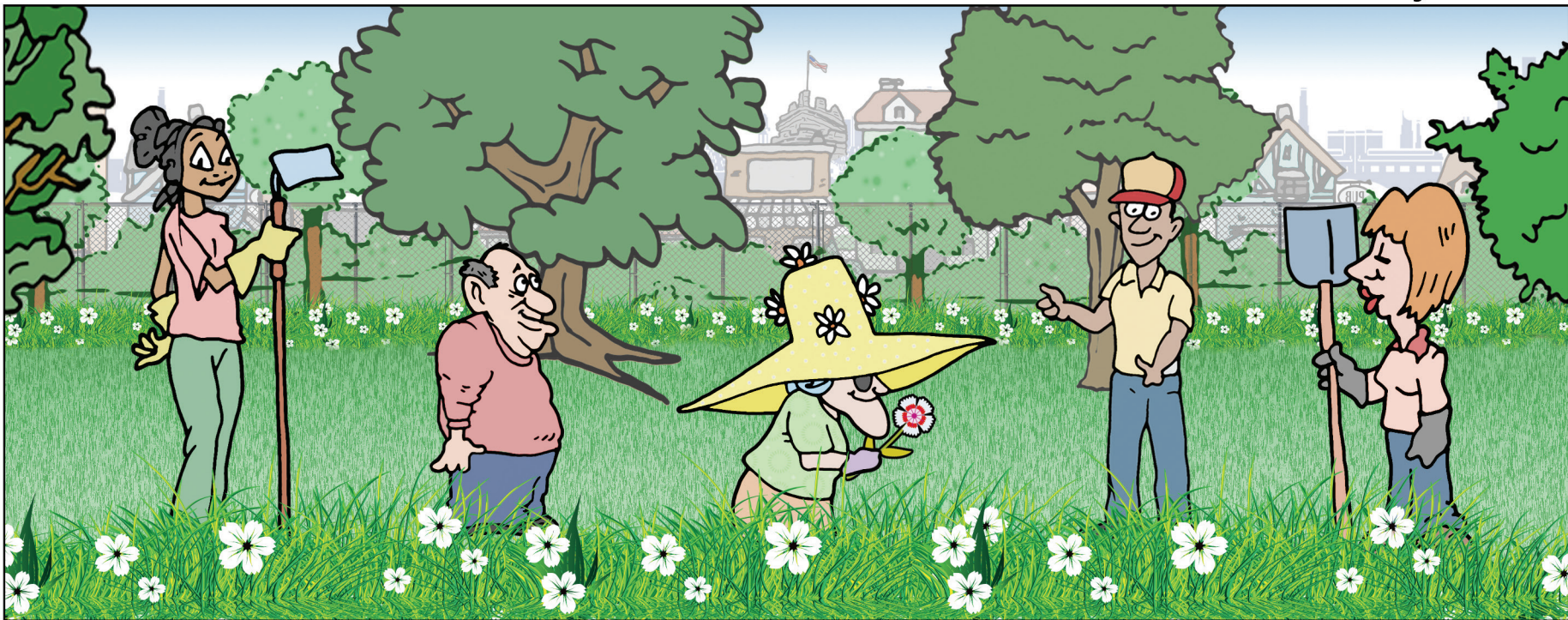

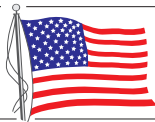

Our View Of The Times



If there's one thing most New Englanders agree on, it's the beauty of our natural surroundings, from our lush forests and picturesque mountain ranges to our thriving wetlands and spectacular coastline. We are indeed blessed with the best of what nature can offer.
In keeping with the spirit of preserving the natural habitat, the Somerville City Council recently passed an ordinance,

the first of its kind in the country, known as "The City of Somerville Native Planting Ordinance," which demands that native plant species be planted on city-owned land.
According to the city, the ordinance recognizes that in New England, there are 258 plant species recognized as endangered, and it states that its intent is to protect and promote appropriate native

vegetation.
The ordinance requires that 100% native plants be introduced in wetlands areas, plazas, and along the Community Path, among other places. Seventy-five percent of new trees planted in city parks must also be native plantings, while 50% of street trees must also be native plants.
The experts point out that native plants evolved to live in this ecosystem over

millions of years. They provide food and shelter to butterflies, moths, birds, bats, bees, and many other fauna, that also evolved to survive here. Plants are the foundation of the food web, and without them and the insects that rely on them for their own survival, life as we know it would disappear.
This appears to not only be a good thing to be doing, but also a vital one.

Cod en papillote

Cod en papillote, French for enveloped in paper, or cod al cartoccio, Italian for folded pouch is a method of cooking that uses the moisture of the food or an additional liquid, like wine, lemon juice, stock, or water to steam the food while baking in the oven or on a grill.

This is a great way to feed a crowd and can be easily made ahead and stored in the refrigerator and baked off about 20 minutes before serving. Here are detailed instructions on how to fold the parchment around the fish, <https://www.finecooking.com/article/how-to-fold-and-bake-fish-in-parchment-paper>.

The results are a flaky, moist fish with crispy steamed vegetables. Definitely a great way to cut down on calories.

2 (6-8 oz) pieces of cod loin 1-1/2" Thick

1 Medium shallot, thinly sliced

2 Small Carrots, julienned 1/4" and/or 4 baby bok choy, cut in half

1 Teaspoon ginger, grated

1/2 Teaspoon dried thyme or 2 fresh sprigs of thyme

1 Lemon, 4 thin slices, plus a squeeze of lemon juice


Salt and pepper

2 pieces of parchment paper or aluminum foil (12"x16")

Excellent quality olive oil for finishing

Preheat oven 400°. In a medium bowl, add the shallot, carrots and/or bok choy and grated ginger. Season with salt and pepper and stir the mixture to incorporate the flavors. Prepare the parchment, see above instructions.

Add the shallot and vegetable mixture between the 2 pieces of parchment. Season the fish with salt and pepper, and place on top of the shallot and vegetable mixture. Add the thyme, squeeze of lemon juice, approximately 1 teaspoon each serving.



Place the lemon slices on top of the fish and fold the papillote.


Bake on a sheet pan for 15 minutes. Add an additional 2 minutes to baking time if made ahead and stored in the refrigerator. Cut open the pouches, exposing the fish, but don't let the juices run out.

Drizzle with a good quality fruity olive oil and serve on a plate. Serve with a side salad.

The **Walk for Hunger** is seeking participants to join our community dedicated to doing good by helping get food to kids and families during the pandemic. A virtual fundraiser that supports **Project Bread's** work to increase food access for people of all ages in Massachusetts, registration opened on **Tuesday, February 9**. Fundraising **continues until May 2**, with fun, virtual events taking place

throughout the day. In its 53rd year, and its second year as a virtual event, thousands of caring community members will participate in the oldest pledge walk in the country, which is expected to raise over \$1 million to help get food to kids and families during this crisis. Like-minded organizations that fundraise as part of The Commonwealth by forming teams can raise money to support their own work, while also furthering the statewide effort. There is no registration fee this year or fundraising minimum. The **state** has announced when all remaining groups will be eligible to receive the **COVID-19 vaccine. Monday,**

April 19: People age 16 or older will be eligible. For more information and to pre-register for an appointment, visit mass.gov/vaccine or call 211. The city of Somerville is also available to help those who face barriers to accessing vaccines, including people who need transportation or language assistance. If you are currently eligible to receive a vaccine and need help accessing the vaccine, please call 311.

Some **reopening restrictions** have started to ease since **April 5**. As more residents have access to the COVID-19 vaccine, including essential and service industry workers, the City of Somerville is moving forward with some additional modest business reopening steps. Somerville is still reopening at a more cautious pace than the state, remaining in a modified Phase 3, Step 1

of the state’s reopening plan until further notice. Starting April 5, restaurants have been allowed to stay open beyond 9:30 p.m. until their regularly permitted closing hours, but must remain at 25% indoor capacity. The city will work with recreation facilities to expand their operations in ways that are safe for each business. The **Somerville Museum** has been allowed to open, but must adhere to special event capacity caps in effect citywide of 10 persons indoors and 25 persons outdoors. The City of Somerville continues to monitor COVID case, vaccination, and other related data on a daily basis. As more people are vaccinated there is hope for further reopening in the near future, but guidance from public health experts does not support further openings at this time given the recent increase in case numbers across the state.

Boston National Poetry Month Festival, 2021:

Virtual, virtuoso poets and musicians April 15-17

The 20th annual B.N.P.M.F. almost happened in 2020. Instead, the 20th Festival is taking place this year, on Zoom. Certain things change—like everyone saying “Zoom.” One constant is Somervillians being a notable part of this event. I could easily fill the entire page by mentioning everything that Doug Holder (professor, publisher, interviewer, etc.) does for poetry, and the arts in general. But I’ll just say he’s a Festival board member, and one of this year’s featured poets.

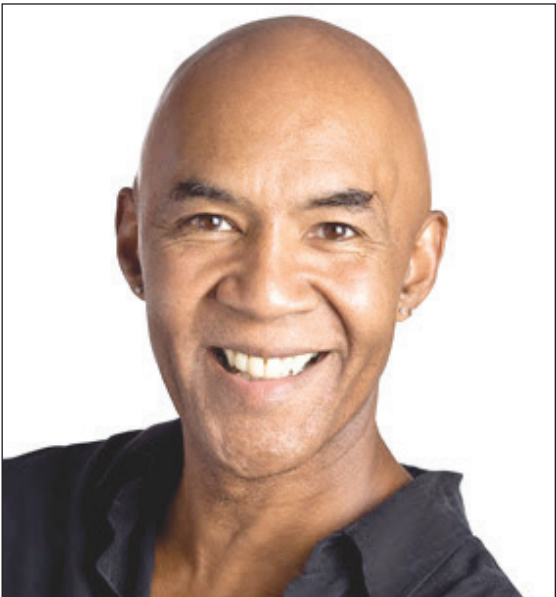
2021 is the first year that musician-plus Stan Strickland will be performing. I don’t know exactly what he’ll be doing, but it could be almost anything: besides his collaborative, multi-instrumental work with all kinds of famous folks, his one-man show Coming Up For Air won the Eliot Norton Award.

(NOTE: When I ran into Stan a few months ago in Union Square, he may have said that he was going to be moving. But it’s easy to misunderstand someone when you’re both wearing masks. Plus, I really, really don’t like the thought of our fine city losing someone of Stan’s amazing talent and generosity to some other city. So enough about that.)

OK! Let’s talk about Lucy Holstedt, who has lived in Somerville for about 20 years. Like Stan, she’s a professor at Berklee College of Music. Lucy is a Festival board member and co-producer. She also created the website, which includes bios of all the poets and musicians. Check out bostonnationalpoetry.org

You’ll find singer-songwriter Thea Hopkins’ bio under the “Saturday” tab. Yet another Somerville resident, her work has been recorded by Peter, Paul & Mary, and the Prague Symphony Orchestra. Thea’s voice is perhaps one of the most beautiful things in the world.

I, too live in this unique city. Among other things, I’m one-third of a bi-coastal group, Cedar Gate



Somervillian, singer, saxophonist, flutist, actor, Stan Strickland has performed with or opened for everyone from Miles Davis and Aretha Franklin, to three-time U.S. Poet Laureate Robert Pinsky.

Writers (Lucy Holstedt is another third). We’re also performing on Saturday.
