## Somerville's Nicotine-Free generation policy begins



The Somerville Board of Health recently voted for the city to adopt a Nicotine-Free Generation policy.

This spring, Somerville's Board of Health (BOH) voted for the city to join a growing national movement to create a Nicotine-Free generation by adopting new public health regulations limiting the sale of nicotine products, which went into effect May 1.

The updated rules, adopted unanimously by the Somerville Board of Health on March 25, mark the start of a major local effort to prevent nicotine addiction, especially among youth.

#### Under the new regulations:

Somerville will begin implementing a Nicotine-Free Generation policy. Anyone born on or after January 1, 2005, will be permanently ineligible to purchase tobacco or nicotine products in the city, even once they turn 21.

Nicotine pouches can now only be sold in adult-only retail stores. Retailers

## Q's Nuts closing Somerville location in June, to be replaced by do-good bakery


A local nut roaster, Q's Nuts, is transitioning operations more online and closing its brick-and-mortar near Davis Square in June, while bakery and pastry shop Hearth & Hug Bakery takes over the lease. "Somerville is an amazing community in terms of the people ... the customers and the fellow businesses that we've met," shared co-owner Beth Quinn. "The neighbors, the people that come in. We have a lot of regular customers, and for that, I'm sad."

Started as an event roaster in 2000 and known for their chocolate-covered and spicy nut flavors, Q's Nuts artisanal offerings have become a fixture in locally crafted food in Somerville. They have seen much growth and changing customer behavior. Before their retirement in a few years, Continued on page 19

## Officials asking for public's help in Somerville fire investigation

Several fires in a former school building are being investigated as suspicious, and officials are asking for the public's help, said Somerville Fire Chief Charles J. Breen Jr, Somerville Police Chief Shumeane Benford, and State Fire Marshal Jon M. Davine.

The Somerville Fire Department responded to 115 Sycamore Street, the former site of the Winter Hill Community

School, at 8:47 pm on May 12. Firefighters made entry, searched the building, and fully extinguished a number of unconnected fires. They also observed other signs of vandalism on the premises.

"This fire had the potential to grow and spread, increasing the danger and risk to responding firefighters," said Chief Breen. Chief Benford, Chief Breen, and State

Fire Marshal Davine urged anyone with information on the fires to contact the Arson Watch Reward Program at 1-800-682-9229. The Arson Watch Reward Program is coordinated by the Massachusetts Property Insurance Underwriting Association and offers rewards of up to \$5,000 for information that solves, detects, or prevents arson crimes.

"The most important thing right now is to prevent any additional fires that could leave someone injured or worse," said Chief Benford.

The fires remain under investigation by the Somerville Police Criminal Investigation Division, Somerville Fire Department, and State Police fire investigators assigned to the State Fire Marshal's office.

who do not meet this standard must remove pouches from their shelves immediately.

"The Nicotine-Free Generation policy isn't about taking away rights, it's about giving young people the freedom to grow up without the grip of nicotine," said Bha-

vika Kalia, a member of Somerville Positive Forces. "It's about bold action today to protect the well-being of those who will lead our communities tomorrow."

The Somerville Board of Health encourages retailers and community members to

familiarize themselves with the new rules. These changes reflect the City's continued commitment to a healthier, addiction-free future for its residents. These regulations follow years of local and statewide efforts to reduce access to harmful products, including Massachusetts' 2024 ban on menthol-mimicking tobacco products.





## **Emily Hardt announces run for Somerville City Council**

Teacher, former union organizer, and former nonprofit executive director Emily Hardt has an-nounced her candidacy for Somerville City Council to represent Ward 7. An over 20 years Somerville resident, Emily is a long-time local climate justice advocate and parent leader in the Somerville Public Schools.

Hardt says she is running to ensure that Somerville is a place where anyone who wants to live, work, and raise a family can do so. "I have seen many friends and neighbors priced out of Som-erville, whether as renters or homeowners. As city councilor, I will work to expand existing initiatives and find new creative solutions that allow people to stay in their homes and neighbor-hoods."

For Hardt, that means every Somerville resident. Hardt will lead on addressing

issues stemming from the attacks by the Trump administration, including climate resilience, immigrant rights, helping local businesses weather the uncertainty of this moment, and supporting schools under attack from federal authorities. "As a long-time Somerville resident and parent in this community, I know the importance of strong and effective leadership to counter the hor-rible policies, massive budget cuts, and hate-filled attacks coming from the federal administration."

An effective leader with years of experience in the Somerville area, Hardt has helped the Somerville Chapter of Mothers Out Front hold utilities accountable for gas leaks, resulting in im-proved air quality and replacing damaged green space. In her role as Executive Director of the Women's Insti-

tute for Leadership Development (WILD), promoting women's leadership in the Massachusetts labor movement, she doubled the organization's budget, expanded multilingual programming, and built strong partnerships with unions and community groups. As a union or-ganizer with UFCW, Emily organized frontline workers, helping hundreds gain union represen-tation and workplace protections. "As a community activist, former union organizer, former nonprofit director and now teacher of public policy, I've spent the past 25+ years bringing people together to develop solutions to big problems," Hardt says. "I can't wait to put my leader-ship experience to work on behalf on my own community right here in Somerville."

#### LTE Students Facing Homelessness and Now Fire at Winter Hill

Dear Editor.

One of the most acute stresses of human rights in our city – students facing homelessness--is seen as students cope with the enormous forces driving our housing crisis. Let me report startling numbers shared from the School Committee. Earlier this winter I learned that the school year in our district opened with 111 students facing housing instability. 79 K-8 students became 61 after the Holiday break as 18 moved to shelter or out of state.

And among the remaining 49 students in grades 9-12, 19 are unaccompanied minors. Deserved thanks for compliance with the McKinney-Vento Act goes to Regina Bertholdo and Jennifer Ochoa who work directly with our homeless families.

On top of the dislocation to the Edgerly Building following long neglected repair – now our Winter Hill School is literally on fire! Anyone could break-in Tuesday, with all the windows left open, necessarily, to let the smoke out of the building. Sycamore street neighbors at 10pm were approached for video in search of information that might lead to arrest.

But the danger to our community--the peril at the heart of the scare for me--is that our Winter Hill students are facing the most difficult situation in the School District. I should know, I have served as an intermittent substitute once in the fall and spring, working with students with Autism, Seventh and Eighth grade English Language Learners. My daughter is a Wildcat, my wife Emily Hankle serves on the PTA as co-vice president, and yes, I'm very well aware of the building committee frustration. But infrastructure is half the battle.

Attracting quality educators with meaningful work and a devoted caring commu-

nity is not the problem. But retaining them at sufficient salary levels is vital if we are to triage performance levels. As put to the School Committee in its budget meeting Wednesday May 7th, Mr. B, our Winter Hill Dean stated that according to MCAS scores – it confirms Winter Hill is in the most dire need of support.





#### Lawrence Joseph "Larry" Balboni Jr.



Lawrence Joseph "Larry" Balboni Jr., died Monday, May 5th, 2025, at his home in Naples, ME after living an amazing 100 years!

Larry was born in Cambridge, MA November 2, 1924, predeceased by his parents Lawrence J. & Rose (Porte) Balboni and siblings Ruth C. Balboni, Eleanor R. (Balboni) Ularich, and Robert A. Balboni.

He was a proud supporter and member of the Appalachian Mountain Club and Audubon Society. While residing in Naples, Larry became an involved member of the community. He was the director of Lakes Environmental Association (L.E.A.) as well as a member of the town planning board, town budget committee, and a trustee of the Naples Public Library. #### The Mariners

At the outbreak of the American Revolution, Lieutenant Colonel John Glover already had twenty-one years under his belt as the commander of Marblehead's militia. Late in the afternoon of the battle of Lexington, his militia narrowly missed a chance to intercept the retreating British column.



It was close. The English barely escaped through the shallow waters of Charlestown Neck, the site of today's Schrafft's City Center, when hundreds of Marblehead mariners and Salem militia surged over Winter Hill. These Minutemen were unique because they were all sailors and fishermen.



For the next year, they joined in the blockade of Boston on land and sea. The men were already disciplined in receiving and carrying out orders. They were drilled, well armed, and

hardened by life on and near the ocean. Because of this, General Washington made some of them his personal bodyguards. They were America's first amphibious regiment, known as Glovers Guard.

At the beginning of the Siege of Boston, Washington had to create a naval blockade. Because of Glover's nautical experience, he was chosen to encircle the city from the sea. Colonel Glover enlisted aid from private Continued on page 22



## **Book review: 'A World of Curiosities'** by Louise Penny

Back in 2005, when Louise Penny published her first mystery featuring Inspector Gamache and the village of Three Pines, Still Life [1], an artist and a painting were central to the story. So, it's amusing that in the eighteenth book of the series a different artist and a different painting are the focus.

Very different, and in a sinister

In Three Pines, a letter written by a long-dead stonemason is discovered. In it, the man describes his terror when bricking up an attic room somewhere in the village. When the room is found, the villagers decide to open it up, and there is a wall covered with a painting that includes clues to a murder.

What's more, the proverbial stranger has come to town.


Two, in fact: A young man and woman have reappeared in the lives of Gamache, his second in command and son-in-law Beauvoir, and their team from the Sûreté du Québec after many years. The two were young children when their troubled mother was murdered, leaving them damaged.

So, why have they come to Three Pines, and is it just coincidence that the artwork has been revealed at the same time? And what does it reveal?

Loyal fans of Three Pines will enjoy learning the backstories of some of their favorite characters (how Gamache became a policeman in the first place, how he met Beauvoir and saw his potential) and listening to all the characters make in-jokes with one another. (Warning to the longtime reader, though: this is a serial killer murder mystery involving at least one psychopath, so if you prefer the cozier books in the series, you're out of luck this time.)

Sadly, if you're a first-time reader, you may find yourself wondering who these people are and why you should care about them. Yes, Penny does character sketches of her regulars, but they are so one-dimensional, their traits seem more like tics. Hearing about what they've been through is no substitute for having gone through it with them for the previous seventeen books.

One other thought, which should have occurred to me before: these books are very Catholic. I don't mean preachy or proselytizing, but the whole worldview is about evil and good, sin and forgiveness, betrayal and redemption. The person who first recommended them to me, in fact, was a former Catholic nun turned Episcopal minister. I do enjoy the

series, but as a Jew, I'm realizing that it's foreign to me, and not just because it's set in Canada.

Please do read Louise Penny, and please do NOT start with this one! Start at the beginning of the series [2], knowing that you have many thoughtful mysteries

#### Q's Nuts closing Somerville location in June, to be replaced by do-good bakery CONT. FROM PG 1

co-owners Beth and Brian "Q" Quinn are focused on transitioning operations to their son Aedan with plans to continue to grow their wholesale, Boston Public Market [1], and online businesses.

Q's Nuts shifted to wholesale roasting in the 2000s before opening its roasting, packaging, and retail facility on Highland Ave. at Cedar St. in 2012. Eight successful years later, COVID hit, and they noticed a "major shift in how people buy things ... people are shifting away from brick and mortar and they're shopping online."

As small business owners who have to decide when to pivot and change, she and Q decided that their business has to "shift with the times." Three years ago, Beth and Q bought a 5,000 square foot commercial kitchen and storage facility in Methuen, and with rising costs and changes to buying behavior, they do not need the Somerville location anymore for cooking and packaging. "Somerville is a very special place for us and we were attached to it too, but it's really...", Beth's voice trailed off.

Also, in their experience, the neighborhood has changed. There used to be more

college students in the area, and now there seem to be more "condos" around. They do "brisk" retail online, and they still operate a Boston Public Market retail stall, which is above the Haymarket green line station and has dollar-per-hour parking.

Plus, just because they are closing in Somerville does not mean people cannot buy their product, Beth wanted to make clear. Folks can buy case flavors online, and Beth is willing "to ship anything they bought in our store in Somerville...we're looking at ways to make it easy for people to maybe not stop in the store anymore, but still support us and still get the products that they love."

With two years left on the lease and good landlord relations, Q's referred pastry shop Hearth & Hug Bakery [2], to take over the space. The bakery, run by an alum of Flour Bakery, Modern Pastry, and Union Square Donuts, raises funds for charity every three months and donates 10 percent of the sales of a chosen pastry.

talie Hug met at the public market, and Natalie wanted to open a space beyond the public market. "We started to talk to her about our space. She came and looked at it. She really loved it. She's a really good person and runs a great business. So we felt the transition would be seamless, and we also felt we were kind of saving our landlords from uncertainty."

With one business graduating from

Somerville and another from Boston, it feels more certain that the corner will still be as sweet, savory, and local as before.

#### Q: What can my landlord use my security deposit for?

A: The only things your landlord can use your security deposit for is any unpaid rent at the end of your lease or the cost of damages beyond normal wear and tear. Normal wear and tear includes the need for repainting, broom cleaning and replacing worn flooring. In addition, you should not be charged for the costs of repairs for normal wear and tear in common areas either. Your landlord should give you a receipt of every repair paid for by your security deposit within 30 days of the end of your lease.

donors by asking for the use of their ships to be armed for the cause. This became Washington's Navy with the first ship being christened the Hannah, after Glover's wife. It was the first vessel of the United States Navy.

The most successful of Washington's schooners, the Lee, was commanded by Captain Daniel Waters of Somerville and named after General Charles Lee, second in command of the newborn Colonial Army. His headquarters were at Winter Hill on today's Sycamore Street. During the blockade, the Lee captured 27 enemy vessels.

After the Siege of Boston, the Americans moved south to protect New York and Long Island. General Glover and his troops saved 9,000 Continental soldiers and equipment during a rainy, nighttime evacuation. Later, during the New York campaign, his regiment held fast against five-to-one odds during a British attack.

During the Christmas blizzard in 1776, Glover and his Marblehead mariners again proved their resilience and determination. They twice transported Washington's Army with their horses, cannons, and gear across the Delaware River in the attack on Trenton, New Jersey.

The Marblehead Militia distinguished itself in the Battle of Saratoga, where 5,763 prisoners were taken. They were appointed to escort the captives to Massachusetts. Forty-two hundred of these prisoners were taken to Prospect and Winter Hills in Somerville where they would spend the

Glover's Guard then spent the terrible

winter of 1778 with Washington and his troops at Valley Forge. During the remainder of the war, his intrepid troops fought and carried out numerous amphibious op-

The United States Navy named a modern ship after Glover, and his Marblehead home is a National Historic Landmark. The General Glover statue on Commonwealth Avenue in Boston honors him and his men for their accomplishments from the waters of Charlestown Neck to the waters of Yorktown, Virginia.

Part of Marblehead's sacrifice was 448 widows and 968 orphans. Through the years, their militia was described as the Army regiment that gave birth to the United States Marines ... the "soldiers of the sea."



# In 'Shadows of the Seen' Timothy Gager Offers a Raw, Relentless Portrait of Inner Lives on the Brink


Timothy Gager has long been a fixture in Boston's literary underground – a prolific writer, spoken-word regular, and a familiar face to anyone who's spent time at the intersection of art and recovery in New England. With *Shadows of the Seen*, his latest and most ambitious novel to date, Gager steps fully into the national conversation with a work that confronts the psychic aftershocks of gun violence, addiction, and political hypocrisy in modern-day America.

Set in New Jersey and Tennessee, *Shadows of the Seen* follows four interwoven characters whose lives are quietly unraveling. The book opens with Candace, a politician whose well-curated image is shaken after a mass shooting forces her to reckon with both her platform and her past. Her storyline anchors the book, providing a moral throughline for a novel more interested in psychological depth than linear plot.

Gager, who has written candidly about his own struggles with depression and substance use, brings a clinician's precision and a poet's empathy into his work. Nowhere is that more evident than in the character of Lucky – a man ravaged by addiction and brain lesions, whose purpose reads not as hopelessness, but as unfiltered honesty. His chapters are not easy to read, but they are among the most affecting.

There's also Peter, whose blackouts and panic attacks suggest a life teetering on the edge of violence. His sections simmer with dread, not because he's a threat, but because Gager so effectively captures the experience of mental illness from the inside out – confused, circular, and terrifyingly isolating. Then there's Bobby-Joe, a political opportunist, husband of Candace, whose self-interest serves as a foil to Candace's late-breaking conscience. Though less nuanced than the others, he adds a necessary bite of satire to a book heavy with emotional weight.

This is not a novel that traffics in silver linings. Gager doesn't resolve trauma, he dissects it. The structure is fragmented, the tone often bleak, and the emotional realism unflinching. That can make for a difficult read—but it's also what makes the book feel honest. Shadows of the Seen doesn't sensationalize



mental illness or addiction; it renders them with the flat affect of lived experience.

At times, Gager's reach exceeds his grasp. The political themes, while timely, are occasionally over-explained, and the multiple narrative voices don't always maintain the same level of complexity. But when the novel is at its best— which is often— it pierces. The writing is sharp, direct, and deeply felt.

For readers familiar with Gager's poetry or his personal essays, *Shadows of the Seen* will feel like a culmination— an artist applying his hard-won insight to fiction that dares to look at what most of us try to avoid. For new readers, it's a bracing introduction to a voice that doesn't flinch. In a literary market full of polished detachment, Timothy Gager is doing something riskier: he's telling the truth, no matter how raw it is.
