

City lends support to state efforts to provide stimulus funds to immigrants



The Somerville City Council passed a resolution last week expressing its support for bills put forward in the state House and Senate calling for equal stimulus funds for immigrant taxpayers.

A resolution was put forward at the latest meeting of the Somerville City Council offering its support of HD.5036 and SD.2916: An Act to provide equal stimulus checks to immigrant taxpayers.

Speaking in favor of the resolution and commenting on the introduction of the state level bills, Councilor At-Large Wilfred N. Mbah said, "We all know that in this crisis there are people who work and pay taxes and they do not qualify for unemployment benefits. So this will address just that. And thanks to our formidable State Rep. Christine Barber for filing this bill at the state level. In the House, Christine Barber filed the bill with Tricia Farley-Bouvier. And also at the Senate level we had Senator Jimmy Eldridge also presented this bill in the Senate. I really want to give a shout Continued on page 4

Somerville Open Studios takes to cyberspace for a change

Last weekend, the annual Somerville Open Studios (SOS) event took place, but not in its traditional form. The citywide art event happened online from noon to 6:00 p.m. on the SOS website, featuring virtual galleries by 336 artists, and also on the SOS YouTube channel, where nearly 30 artists posted videos of their work and studios. During the event, six artists held Zoom livestream tours of their studios for virtual audiences.

For the past 22 years, Somerville Open Studios has been an event where artists in the city open their doors to visitors who want to tour these artistic spaces. All forms of visual art are featured, including painting, printmaking, jewelry, photography, and fiber arts.

During the weekend, there is normally a trolley system in place to transport visitors easily around the city to view the exhibits and studios, and the city lifts residential Continued on page 4

Last week Gov. Charlie Baker announced that starting Wednesday, May 6, face coverings will be required in public in all cities and towns throughout the state. The statewide order does not apply to anyone under the age of two or anyone who is medically unable to use a face covering. Last week Somerville officials put an order mandating the wearing of face masks in public. Everyone age 2 or older must cover their faces in any public indoor or outdoor space. A scarf, bandana or any clean cloth will meet the city's requirement. The city may impose fines of \$300 on those who "willfully refuse to comply" with the face-covering order. Mother's Day revisited



Mother's Day is Sunday May 10. Lots of us have sweet memories of getting mom that special gift that she so richly deserved.

When I was six (1959) I walked to Ball Square and bought my mom an apron at the (Savel's, I'm pretty sure) 5 & 10. I paid for it with a special silver dellar that I had received as a high

silver dollar that I had received as a birthday gift from former Somerville politician and all around nice guy Lenny Scott. We lived downstairs and became like family with Louise and Lenny and the kids.

After my Dad found out that I had spent the rare silver dollar, he went down to Savel's and got the silver dollar back. Can you imagine paying one dollar for an apron? I can still picture the frilly pattern in my mind and I still have the 1882 silver dollar. We also still have a pair of candle-



sticks that I bought for my mom at the Bargain Center (they sold fire and smoke damaged items.)

Here are a few stories from some of my Somerville friends as we recalled Mother's Day gift buying in the simpler days of Somerville.

"I was 16 years old, working part time and put a mothers ring on layaway. A mother of seven, mom always wanted a mothers ring. She got it for Mother's Day 1968. I've had it since 2015."

"I remember my brother and I going to Mahoney's for Easter Lilies."

"My siblings and I walked to the Coronet Restaurant (Redbones today) for Mother's Day dinner with my mom who was working as a server."

"My mom was a smoker. I got her an ashtray from Kresges. I was eight. My sister reminded me."

"Buying a rose for my mom at Murphy's Florist when we were old enough to walk to Davis Square by ourselves. They always added baby's breath and wrapped it up nice (I'm sure our friend Ada at Bostonian Florist will be making many beautiful arrangements)."

"I always bought my mother perfume in a beautiful blue bottle, Midnight in Paris at the 5 and 10. Years later I found out she hated the smell (the bottle was pretty though!)" "I would save my money from baby sitting and buy my mom Jean Nate because she loved it. I always was so excited and proud to give it to her. I miss those days so much."

"Me, my five siblings and my five cousins next door wanted to bake our mothers a cake. We made an angel food cake, but we all put in a drop of different color food coloring. It came out BLACK! It had red, green, blue, yellow and orange frosting!! It was the most disgusting looking cake you ever saw but it tasted delicious!"

"When I was 10, I wanted to give my mom something really special. I went to the store for her to get her, of all things, Juicy Fruit Gum like she asked. On my way there I found a 50 and a 20-dollar bill. Feeling rich, I got my mom two packs of Juicy Fruit and some of her favorite perfume, Heaven Scent. I went home gave her the gifts and the envelope with \$70 dollars in it. Needless to say she wanted to know where I found the money and I told her. She said thanks but we need to bring it to Police Station. Three weeks later the Police returned it to us as no one claimed it in the allotted time."

"My siblings and I lived near Porter Square. We went to Kresge's and bought a large picture to put on the wall behind our sofa. Mom loved the view of my older sibling holding the front of the picture



and me in the back. She loved it."

Mother's Day will be different this year. Phone calls and videos will temporarily replace hugs and kisses, but we will definitely make the most of it. Happy Mother's Day to all mothers everywhere. Stay safe.

parking restrictions so visitors can go between studios easily. However, with the coronavirus pandemic causing citywide closures, shelter-at-home orders, and social distancing guidelines, holding the event in its usual fashion was impossible.

The cancellation of the physical event was disappointing according to SOS publicity coordinator Thea Paneth, who said, "Everyone was absolutely devastated. It's all artists and members of the community working together to make the event happen. Having to cancel it was really distressing, but we saw the way things were going and that it wasn't going to be possible or safe to open."

SOS Board President Hilary Scott said that after cancelling the in-person event, the plans to pivot to a virtual platform were immediate. During the initial discussion about the online transition, SOS organizers decided on two distinct parts: a virtual gallery and livestreams.

With a virtual gallery on the SOS website, artists displayed four to eight pieces of their work, with an added feature of posting video tours of their studios and creative spaces on SOS's You-Tube channel.

After figuring out the gallery, the team then asked, "How can we salvage the live aspect?" They came up with a plan to do Zoom livestreams, scheduling

times for artists to broadcast and invite people into their space. These features brought both live and pre-recorded factors to the event, and links to the art and videos made it even more accessible.

"We're excited that the You-Tube channel is something we can keep going and add more aspects to year-round," Scott said. As a member of SOS since it began 22 years ago, Scott was disappointed to have to cancel the in-person event as they were in the homestretch, but he is still pleased with how the event transitioned. He believes the SOS team "made lemonade when the world served us lemons."

"We can come out of it with a more interesting and fuller experience," Scott said. "SOS is such a physical experience. It's opening up your door and having people walk in, and having to explain to the artist community that they could do this virtually was the challenge," he said, adding, "We said, 'we can do this, and it's worth doing."


Scott believes that the online approach makes SOS more broadly accessible, as people who are not in Somerville can find the YouTube channel and wander into the artists' studios whenever from wherever.

Though the virtual event was a success, Scott felt it was bittersweet since the weather last weekend was perfect, and he missed seeing the hundreds of visitors, especially enthusiastic kids who usually attend.

Changing the event was sudden, but Paneth said that artists and volunteers at SOS offered their individual expertise to join the collective activity of transitioning online. Everyone on the team worked remotely, which was new since SOS members normally meet in each other's living rooms, but now meetings take place over Zoom. Scott said there was a bit of a learning curve at first, but the team got used to the new form of communication.

Watercolor artist and designer Katya Popova agreed that there was a learning curve for those involved. Popova worked on the virtual transition team and was an early advocate of switching online and using Zoom to keep the event going. "We were really intensely working when the whole pandemic happened," she said. "No one was sure if we wanted to cancel the event or if things would get better. We started thinking about other possibilities."

With social distancing forcing the team members to work remotely, Popova worked from New Hampshire, and said that she grew closer with SOS members over virtual meetings. "I'm very grateful that the virtual work happened so we were able to pull this all together," Popova said, adding, "It's kind of a warm

feeling, so I'm grateful to the people involved, because they definitely made it all work."

Scott voiced similar sentiments. "It's a wonderful thing. Some open studios are organized by arts councils, but this is organized hands-on by SOS artists and we do the work ourselves. It means something. We

build community amongst each other working together, and it's really been wonderful to be a part of it all these years."

out to Christine Barber for taking such a profound initiative for putting this forward.

The bill put forward in the House reads as follows:

"Whereas, The deferred operation of this act would tend to defeat its purpose, which is to provide stimulu s checks to immigrant taxpayers who were excluded from the stimulus provisions of the federal CARES Act, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

SECTION 1. (a) When used in this section the following words or terms shall have the following meanings:—

"Commissioner", the com-

missioner of revenue. "Eligible taxpayer", a taxpayer who filed a Massachusetts income tax return for tax year 2019 using an Individual Taxpayer Identification Number ("ITIN") and who is ineligible for the recovery rebate in section 2201 of the federal CARES act of 2020; provided that estate or trust shall not be considered an eligible taxpayer.

"Qualifying child", an individual listed as a dependent by the taxpayer on Schedule D1 of the Massachusetts income tax return for tax year 2019 who is a child of the taxpayer or a descendant of such a child, or a brother, sister, stepbrother, or stepsister of the taxpayer or a descendant of any such relative, who lived in the same home as the taxpayer for more than half of tax year 2019, who has not provided over one-half of the individual's own support for

the calendar year in which the taxable year of the taxpayer begins, and who has not filed a joint return (other than only for a claim of refund) with the individual's spouse under section 6013 for the taxable year beginning in the calendar year in which the taxable year of the taxpayer begins, and who had not attained the age of 17 years at the end of 2019.

(b) Notwithstanding any general or special law to the contrary, in the case of an eligible taxpayer, there shall be allowed as a refundable credit against the tax for tax year 2019 an amount equal to the sum of—

(1) \$1,200 (\$2,400 in the case of an eligible taxpayer filing a joint return), plus

(2) an amount equal to the product of \$500 multiplied by the number of qualifying children.

(c) The amount of the credit allowed by this section shall be reduced (but not below zero) by 5 percent of so much of the taxpayer's adjusted gross income as exceeds—

(1) \$150,000 in the case of a joint return.

(2) \$112,500 in the case of a head of household, and

(3) \$75,000 in the case of a taxpayer not described in paragraph (1) or (2).

(d) The commissioner shall disburse refunds payable under this section electronically to any account to which the payee authorized, on or after January 1, 2018, the delivery of a refund of income tax. In the case of an individual who, at the time of any determination made pursuant to subsections (b) and (c) has not filed a tax return for tax year 2019, the commissioner shall disburse refunds payable

under this section by substituting '2018' for '2019' in the definitions of "eligible taxpayer" and "qualifying child" and in subsection (b). (e) For an eligible taxpayer to whom no electronic refund is disbursed pursuant to subsection (d), the commissioner shall notify such taxpayer by first class mail and provide information prominently listed on the website of the department of the availability of the refund provided for in this section together with instructions on the application process. (f) The commissioner shall promulgate regulations to effectuate the purposes of this section."

The bill put forward in the Senate was functionally identical to the House bill.

The Somerville City Council voted unanimously to approve the resolution supporting these bills.

PorchFest becomes CouchFest in response to social distancing guidelines

Somerville's annual PorchFest is back this year as CouchFest, the same basic event for local musicians to perform at home for audiences, but this year from a safe distance, broadcasting online. Since 2012, PorchFest has been a day-long event where musicians can sign up to perform on their porches or front lawns where audiences come listen to them play.

This year the event was disrupted by the shelter-at-home orders and social distancing guidelines set due to the coronavirus pandemic. The usual format for the event became impossible, so organizers moved it online. Musicians can choose to broadcast live on Facebook, post pre-recorded "premiere" performances, or post an old video of their songs to participate.

Links to the Facebook live performances and music videos will be uploaded to the PorchFest site, where there is a map of locations where every band is playing virtually. Around 60 bands are registered to play, and the audience can click on parts of

the map that are linked to performances, which is supposed to replicate a "virtual music tour of living rooms around town," according to organizers.

One thing is certain: organizers emphasize safety. They announced that under no circumstances should musicians gather to play unless they are already quarantining together. In an email about the event, they state, "Please do NOT gather a band together to play for this. We also ask that you play inside - as playing outside might encourage people to congregate."

Somerville Arts Council executive director Gregory Jenkins said that by March it was clear PorchFest could not take place in-person, but the virtual event will replicate the original event as much as possible. "The intent is still the same," Jenkins said. "On Saturday from 12 to 6, you can go to our website and still peruse a map of the city and see where these various bands are going to be performing virtually." CouchFest is set to take place

on Saturday, May 9, with performance times based on where the band is located. West Somer-

ville musicians play from 12:00 to 2:00 p.m.; Central Somerville play from 2:00 to 4:00 p.m.; and East Somerville from 4:00 to 6:00 p.m.

One Somerville band, Nowhere Lights, has been playing at PorchFest since it began nearly ten years ago. The four band

members normally play on guitarist Mike Murray's porch in Teele Square, with audiences gathering on the sidewalk. This year, with band members living separately, Murray said they could not safely perform together, so broadcasting live was not an option.

"It's pretty easy to livestream if you're alone or if you're with people that you're playing with physically, but separately the latency issues between the locations make it pretty much impossible," Murray said. "You can't play a song together on Zoom. Have you Continued on page 12

Dorothy's Corner



This recipe produces a very satisfying, healthy, and delicious meal. I had a squash that needed to be used up, so I rummaged through my pantry looking for ideas. I always have a variety of beans, grains, nuts, and dried fruits on hand. This is what I came up with.

1 butternut squash, about 1 lb., cut in half lengthwise

1 cup farro, uncooked

2 medium shallots, minced

2 medium garlic cloves, finely minced 1 15 oz. can garbanzo beans, drained and rinsed

2 +1 +1 tablespoons extra virgin olive oil

Zest and juice of 1 lemon Salt 1 teaspoon and pepper 1/2 teaspoon, plus dusting for squash 1/2 cup toasted walnut pieces 1/2 cup dried cherries 1/2 cup feta

Preheat oven to 400°. Cut the butternut squash in half lengthwise. Using 1 tablespoon of olive oil, brush on the cut sides of the butternut and season with a dusting of salt and pepper. Roast until for tender, approximately 25-30 minutes. Prepare the farro according to package instructions.

Meanwhile, place the walnuts into a small, dry sauté pan, and toast for about 3 minutes over a low heat. Place the nuts in a small dish. Return the pan to the heat and add 1 tablespoon olive oil, add the shallots and sauté for 2-3 minutes until they are lightly browned. Add the garlic and cook for 30 seconds.

Add the beans, shallot and garlic, zest, juice, walnuts, dried cherries, and remaining 2 tablespoons of olive oil to the farro and stir until well incorporated. Spoon the mixture over the squash, add the cheese and serve. If you don't have dried cherries, you can substitute dried cranberries.

If you don't want to use feta, goat cheese would make a great alternative. I would also suggest adding some fresh herbs if you have them. Either mint or parsley would add a nice touch. There will be leftover farro from this recipe. It makes a great side to any meal or as a meal in itself.

Representative Barber files legislation to support immigrants during COVID-19 pandemic

State Representative Christine P. Barber (D-Somerville and Medford) filed legislation to provide state-funded financial support to immigrants who were excluded from the federal stimulus bill, in response to the COVID-19 crisis.

Rep. Barber recently filed HD5036, An Act to Provide Equal Stimulus Checks to Immigrant Taxpayers with State Representative Tricia Farley-Bouvier (D-Pittsfield). This bill would provide a state-funded stimulus check to Massachusetts ITIN holders who file taxes but are not eligible to receive federal relief under the recent Coronavirus Aid Relief and Economic Security (CARES) Act.

ITINs (Individual Taxpayer Identification Numbers) are issued by the IRS for tatt filing purposes to individuals who are ineligible for Social Security Numbers. ITIN filers include undocumented immigrants and other vulnerable groups who pay taxes through alternative means. There are an estimated 57,000 ITIN filers in Massachusetts, yet the CARES excluded ITIN filers and their families from receiving critical stimulus checks. Families in which one member files their taxes with an ITIN, even if the other members are U.S. citizens or otherwise file with a Social Security Number, are also excluded from the stimulus funds – a significant issue which this legislation would also address.



"It is important for our state to step up to fill this gap left by the federal stimulus bill," said State Rep. Barber. "These are our neighbors--members of our community who are paying their taxes but have been excluded from the financial assistance that has been critical for so many. This bill attempts to level that playing field to ensure that no members of our Commonwealth are left behind during this crisis,"

Rep. Barber is working with partners including the Welcome Project, the Brazilian Workers Center, the Massachusetts Immigrant and Refugee Advocacy (MIRA) Coalition, the Massachusetts Law Reform Institute, and the Massachusetts Budget and Policy Center, and others to advance this legislation. This bill is currently before the — Office of State Rep. Christine P. Barber Joint Committee on Revenue.

Keeping personal information

Americans are spending more time at home, which means they're likely spending more time online. While their attention is focused on staying healthy, they shouldn't forget to stay vigilant about cybersecurity either.

The FBI recently warned that cybercriminals are taking advantage of the current environment to steal personal information and money. The scams come in various forms, including fake emails from the Centers for Disease Control and Prevention and World Health Organization claiming to offer new information on the virus; emails asking users to verify personal information for an economic stimulus check from the government; and emails selling counterfeit COVID-19 related products or treatments.

Personal health information can be a target for hackers too.

According to the Office of the Inspector General, personal health information (name, social security number, Medicare number) can be stolen and used to file false Medicare or other health insurance claims. If this occurs, individuals might experience a disruption in medical care should they need it.

Bob Davis, deputy chief information security officer, Cigna, has a few simple steps to protect individuals and families from threats.

· Never open email or attachments from unknown senders. Many scams occur when clicking on fraudulent links or attachments in emails. Sometimes these emails can look similar to those received from legitimate sources, such as a health insurer, making it difficult to notice the difference. Pay attention to details: does it look like other valid communications you've received? Is the sender email address correct? To check a link's legitimacy, hover over the text to see where it will redirect.

Also note, when communicating with health insurers online, it will likely be done through a secure email portal, which automatically encrypts (secures) emails and can only be accessed by signing in using a pre-determined password.

- · Guard personal information. As a general rule, health insurers will never ask for credit card information or account passwords in an email. Report emails asking for this information to your health insurance company immediately.
- + Hang up and call back. Not all threats occur online. Be wary of phone calls from someone claiming to be your health insurance company asking for personal information. To confirm legitimacy, simply hang up and call the customer service phone number listed on the back of the insurance card. In most cases, if information or payment is needed, individuals will receive a letter in the mail, not a phone call.
- · Monitor texts and social media. Many use cell phones as a primary way to communicate, so it should be no surprise that cybercriminals are turning to text messages as a way to steal information. Text messages should be approached the same way as

emails. Don't click on links or share information with unfamiliar numbers. Same goes for social media. Don't click on suspicious advertisements or links.

 Remind friends and family. Just like friends and family are reminded to stay healthy, the same should be done with cybersecurity threats. Remind loved ones, especially the elderly, to pay close attention to unsolicited emails and calls, and to limit the information they share over the internet. If seniors think that they may have been victim of a scam, they should contact Medicare as soon as possible at 1-800-MEDI-CARE. (StatePoint)



- Case Counts: As of 8:30 p.m. yesterday, May 4, a total of 639 Somerville residents have tested positive for COVID-19, 277 of them have since recovered, and sadly there have been nine deaths.
- Face coverings required statewide: Last week Gov. Charlie Baker announced that starting Wednesday, May 6, face coverings will be required in public in all cities and towns throughout the state. The statewide order does not apply to anyone under the age of two or anyone who is medically unable to use a face covering.
- More capacity at the Department of Unemployment Assistance (DUA): To better help the more than 650,000 Massachusetts residents who have applied for unemployment since the COVID-19 crisis began, DUA has expanded its call center capacity. The DUA call center at (877) 626-6800 now has 1,200 employees, up from 50 pre-crisis. Multilingual call agents are available.
- Pick up the phone for contact tracers: If your caller ID tells you that "MA COVID Team" is calling, that's one you should pick up. Staff from the State's Community Tracing Collaborative are calling people who have been in close contact with someone who tested positive for COVID-19 to make sure they're aware and to share information about healthcare and quarantine procedures.
- Extended deadline to apply for insurance through the Health Connector: An extended enrollment period is available through May 25, for qualified Massachusetts residents who are uninsured. Anyone who has recently lost their coverage should apply. Learn more at mahealthconnector.optum.org.



Murray said it is harder than he expected to stitch the clips together with his editing software, trying to line up the audio for the tracks perfectly.

"PorchFest on a beautiful spring day is a pretty magical event where people are just having a great time and it's really fun. It's hard to imagine that there's

going to be quite as much as excitement around this, but I'm psyched to do it," Murray said, adding that it's fun — and frustrating — to learn the editing software, and he likes that he can create something that people can view more times in the future.

Somerville Artist Allison Tanenhaus:

A Public Artist in the time of the Plague

Allison Tanenhaus is a self-taught digital abstract glitch artist who specializes in abstract geometrics, vibrant color fields, optical perspectives, playful patterns, mind-bending motion, and unexpected dimensional qualities. Applications include public art, street art, and commercial art, branding design, and multimedia presentations and performances.

Recent commissions and installations include Bulfinch Crossing, the ICA Store at the Institute of Contemporary Art/Boston, New England Synth Fest, Boston Convention & Exhibition Center, and "GlitchKraft: Allison Tanenhaus + Friends" at Emerson Contemporary. She frequently creates music videos and album art for electronic musicians in Somerville, including The Square Root of Negative Two and Doug Bielmeier.

Doug Holder: What is your connection to Somerville? What part of town do you live in, for how long, etc.?

Allison Tanenhaus: I've lived right outside Davis for 16 years.

DH: What makes this city unique?

AT: There's an authentic adoration for hard work, progress, creativity, and connection that I really vibe with. We have lively art and music venues, delicious and diverse restaurants, and other big-city benefits, but there's a small-town flavor that permeates, which I find comforting and appealing. There's also deep respect and support for the artistic community – from the top of the administration on down – which is vital and much appreciated.

DH: What are you working on now?

AT: I'm working on creating and compiling short animated clips to pair with sound samples from local musicians. Mini music videos, essentially. The plan is that we will each post on social media to cross-promote the endeavors in our respective mediums, as well as prompt ourselves to stay active in the creative process.

DH: What projects do you envision for the future?

AT: I'd love to continue creating multimedia installations for galleries and other venues, but those opportunities would only be online for the time being, which does cut down on immersive and collaborative qualities. Hopefully when the world opens up again, there will be an invigorated appetite for new public artworks that everyone can joyfully experience out in the open.

DH: Is your work now influenced by the virus? Do you think it will be in the future?

AT: I'm finding that I'm becoming more experimental – trying out new techniques, styles, and technology – so that I can stay nimble and relevant. My work is mostly abstract, so I don't know



if the virus's impact on my art is apparent yet. Perhaps more obvious themes or imagery will emerge, especially when looking at a body of work collectively and in hindsight.

DH: It is hard to make a living as an artist – period. How has this situation affected you?

AT: Like many artists, I make a living from various simultaneous streams. In my case, it's creating art installations that are either environmental. For example, building wraps, wallpaper, prints, and digital displays for construction sites, train stations, hotels, offices, architecture firms, and interior design projects. Or in the academic or art gallery world. I also sell collectible art – stickers, postcards, buttons, and tote bags – at in-person markets, plus work as a cat-sitter for the local company Thoughtful Paws.

Since people aren't traveling, I'm not doing any cat-sitting. With galleries closed, I'm not able to exhibit. Art markets are of course cancelled. And since construction and renovation projects are on pause, I can't progress on those kinds of projects, either.

From a distance, my fields all seemed to be unconnected, but through the lens of the pandemic, it turns out they are all reliant on people being able to come together. At home, in public, in entertainment venues, or in new destinations while traveling.

I'm doing my best to stick with art that can be experienced virtually, but there's a huge reduction in opportunities — whether they're exhibitions, performances, or commissions, revenue, and audience connection. And I really miss the kitties I used to cat-sit for!




